

I deal with the behavior scars my husband John has, on a day to day basis, as a result of the maltreatment of the officials when he was 14 years old. I have been with him when he has tried to obtain meaningful employment only to have an owner fire him if he lies about his inaccurate criminal history, or doesn't get hired if he discloses those circumstances on any application forms. My due process rights are violated when his due process rights were and are violated.

I was present when the Kitsap County sheriff deputies came to my mother-in-law's house to evict her even when she openly displayed her land patent, her Justice of the Peace order, and her dismissal from the U.S. District Court in Tacoma Washington. I have read the supporting federal rules and statutes which say all of the causes of actions contained in the removal are dismissed against her ab initio mundi (from the beginning). The sheriff's would not read or listen. They damaged all of our family's property in the house and on the land during the eviction. The eviction process was terminated abruptly, leaving one third of the property on the property. The records are inaccessible at this time.


