

The undersigned affiant, Hugh Brian Street, being first duly sworn, hereby deposes and says:

- 1. I am over the age of eighteen, suffer no legal disabilities, have personal knowledge of the facts set forth below, and am competent to testify.

August 12, 2005 summons #6181741 was given me. On August 12th, 2005, I refused for cause without dishonor and without recourse to me this offer of contract within the required 72 hours. December 19th, received NOTICE OF ARRAIGNMENT. Accepted it for value/returned for value December 22nd. upon Shirley Fontenot providing proof of claim to me or account settles and closes in ten days. Because I was incarcerated in City of Leesville's jail, city of DeRidder put hold on me and wouldn't let me go unless I bonded out from DeRidder. Because of bond, I was invited to their court and attended it on April 11th, 2006 and had to enter a plea of not guilty. Trial was set for me for July 12th, 2006 and when judge Stewart saw the paperwork I had submitted to the court, he became furious and cursed me right there in the courtroom and sentenced me to serve 90 days in the Beauregard Parish Jail. I requested a writ of Habeas Corpus 2 times. Judge Stewart just flat out denied me this. The second request was to Judge Kay who never responded to my request. I HAVE BEEN DENIED DUE PROCESS!




The undersigned affiant, Hugh Brian Street, being first duly sworn, hereby deposes and says:

- I am over the age of eighteen, suffer no legal disabilities, have personal knowledge of the facts set forth below, and am competent to testify.

October 30th 2005, Police Officer for City of Leesville presented me with summons #042946. October 31st, I accepted for value/returned for value with my signature and exemption # via certified mail#7002-0860-6718-2124. November 4th 2005, note left at my door from Leesville City Marshall for 176.00. Went to Arizona for Thanksgiving and was informed Sheriff is hunting me down like a criminal. December 12, 2005 I conditionally accepted for value/returned for value debt upon City of Leesville providing me proof of claim. Again paid with exemption # and signature. Proof of claim never arrived. Sheriff continued stalking my home in order to arrest me. I had to camp out in the cold and couldn't even go home for Christmas because sheriff promised to surround my property. January 10th, 2006 Private Settlement Agreement provided to Sheriff. January 13th, 2006 I was arrested and taken to Leesville City Jail where they held me until they held court for me to go before Judge. January 18th, 2006, I was brought before the judge and never gave him jurisdiction. He entered a plea of not guilty on my behalf and continued to hold me in jail until February 1st., 2006. February 1st, there was a mock trial in which all my private settlement papers were presented yet was completely ignored by judge. I was sentenced to serve a month in jail. I HAVE BEEN DENIED DUE PROCESS

## Ticket Facts

All law is contract law.

## **Writ of a Freeman's Right to Travel**

### **Writ of a Freeman's Right to Travel - Justice Notice - Demand for All Rights Protected by the Constitution for the united States of America**

Know all men by these present, that I, Hugh Brian Street do travel upon the Roadways, By-ways, Highways, and Air-ways of these United States, as a matter of asserted Common Law rights. That I assert my full sovereignty as a free and natural person (Freeman) under the Common Law of the Constitution for the united States of America, to wit:

#### **States Enforcing Un-constitutional Laws**

If some state laws are unconstitutional - are there ways for the states to mandate restrictions on licensing, registration, and insurance requirements? To know, we need to look to the U.S. Supreme Court to determine for ourselves the answers to these questions.

1. "The right of the citizen to travel upon public highways and to transport his/her property thereon, either by carriage or automobile, is not a mere privilege which a City/State may prohibit at will, but a common right which he/she has under the right to Life, Liberty, and the Pursuit of Happiness." Thompson v. Smith 154 SE 579.
2. "The use of the highway for the purpose of travel and transportation is not a mere privilege, but a common and fundamental right which the public and individuals cannot be rightfully deprived." Chicago Motor Coach v. Chicago, 337 ILL200,169 NE 22, 66 ALR 834. Ligare v. Chicago 139 III. 46, 28 NE 934. Booney v. dark, 214 SW 607; 25 A M JUR (I'1) Highways, Sec. 163.
- 3 For a crime to exist, there must be an injured party. "There can be no sanction or penalty imposed on one because of this exercise of Constitutional rights." Sheer v. Cullen, 481 F. 945
- 4 "The right to travel is part of the Liberty of which the citizen cannot be deprived without due process of law under the Fifth Amendment." Kent v.

Dullcs 357 U.S. 116, 125.

5. "Where rights are secured by the Constitution are involved, there can be no rule-making or legislation which would abrogate them." Miranda v. Arizona 384 U.S. 436, 125

6. "The claim and exercise of a Constitutional right cannot be converted into a crime." Miller v. U.S. 230 F 2nd 486, 489.

7. "Under our system of government upon the individuality and intelligence of the citizen, the stat" does not claim to control him/her, except as his/her conduct to others, leaving him/her the sole judge as to all that affects himself/herself." Mugler v. Kansas 123 U.S. 623, 659-60

8. It is reasonable to assume that these judicial decisions are straight and to the point, that there is no lawful method for government to put restrictions or limitations on rights belonging to the people.

9. There is no question that a citation/ticket issued by a police officer, for no driver's license, current vehicle registration, or mandatory insurance, etc., which carries a fine or jail time, is a penalty - and is, indeed, "converting a right into a crime."

10. A corporate entity, whether it be a city, state, or U.S. Government, cannot testify as an injured party, thus cannot be cross-examined.

As an individual one can speak for a corporation, but cannot be an injured party - as a living person of record. In Propria Persona;
